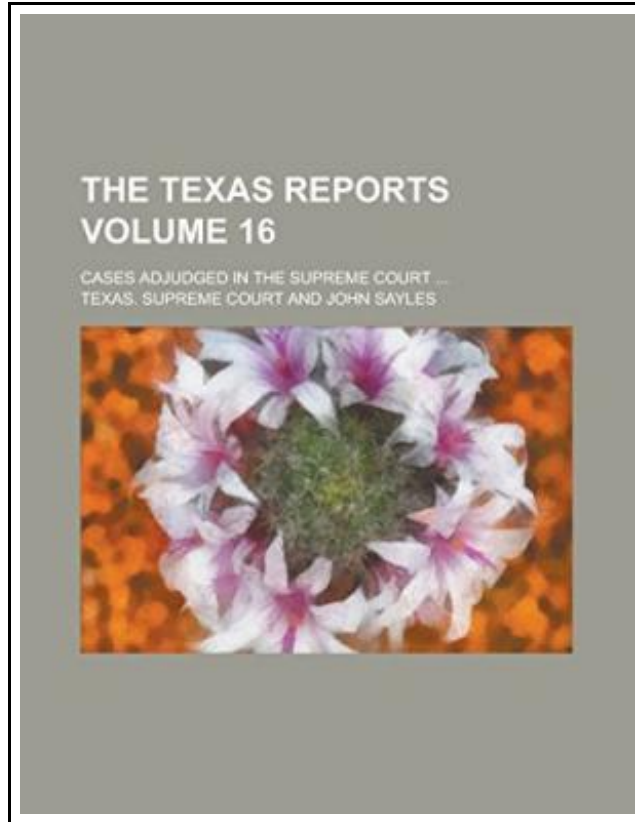

A mere omission in one part of the charge of the Court, if supplied, substantially, in another part, is not sufficient ground for reversing the judgment, where there is no cause to apprehend...
